Case 32-23O EVALMEDHELSE 2023-2024

The Research Council of Norway (RCN) are just starting evaluating Norwegian medicine and health research (EVALMEDHELSE), as the second evaluation of two evaluations in their ongoing process of evaluating Norwegian life sciences 2022-2024. NCMM as a whole is registered as an administrative unit to be evaluated. The NCMM board approved of Terms of Reference for the assessment of NCMM, in June meeting. The Director will update the Board in the meeting on the coming process.

Case 36-23B Long-term budget (LØP)

Case 37-23O Strategy discussion on continuation of NCMM beyond 2024 - update

NCMM is in an interim period since RCNs decision to stop funding after 2024 – ongoing until UiO has decided on new mandate and funding scheme. The NCMM Director presented NCMM to the new Deanship at MED on March 6, and The Director and Chair of the Board attended a workshop organized by the Rector of UiO on March 17. There was also a workshop on June 26. Rectors' ambition for NCMM is to integrate NCMM better into UiO and he has set up a working group to put forth concrete suggestions for the future NCMM. The proposal to the UiO Board for setting up the working group describes the roles of the working group members and a timeline for work. The work group aim to finish this task in the first half of 2024. Which means a full year in an interim period. In this period, NCMM is hindered in keeping up the work by instructions from the Medical Faculty that NCMM must stop hiring until further instructions. (Directors presentation of NCMM at the UiO Board meeting in September and the instructions from the Medical Faculty, dated 21.09.23 is attached; attachment 4 and 5). The Director will update the Board in the meeting about the latest news.
